

A majority of the strategy is dedicated to selling rolling monthly call options on the portfolio's cryptocurrency holdings. The strategy also generates income by participating in "on-chain" opportunities such as staking, liquidity providing and masternodes.


It is the opinion of the General Partner that the strategy will generate annual income in excess of 20%.

**INVESTMENT PROCESS**

- Partnership assets are invested in select U.S.-listed cryptocurrencies that the Partnership's Trading Advisor believes will deliver capital appreciation and monthly income to the Partnership.

- The Trading Advisor independently evaluates the availability and attractiveness of call premiums verses other on-chain income generating opportunities for each of the Partnership's holdings.
- Strategy holdings are actively monitored and may be traded daily.


