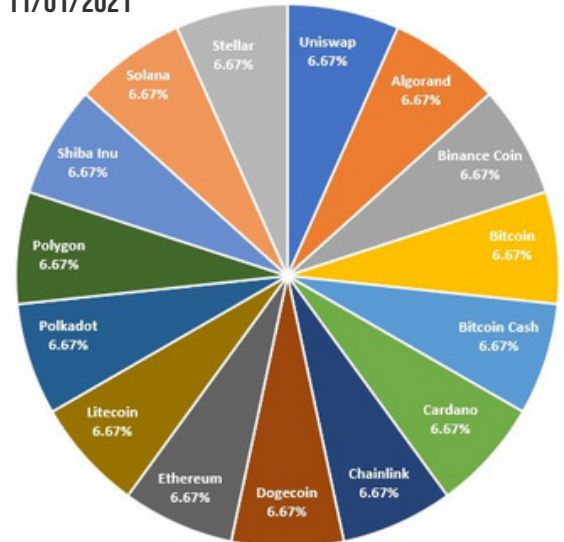

Cryptocurrencies with anonymous transaction features (privacy coins) and those designed to track an underlying currency or commodity (stablecoins, gold-backed tokens etc.) are excluded.	All potential holdings must be listed on authorized U.S.-based cryptocurrency exchanges. ETFMI serves as the Partnership's Investment Advisor and operates with a Fiduciary Standard. ETFMI further protects clients with a \$1 million cyber-theft insurance policy.
